

# CHINOOK FACTS

## ONCORHYNCHUS TSHAWYTSCHA

The state of Oregon designated the Chinook or king salmon as its state fish in 1961.

The chinook is the largest of the Pacific salmon species, the world record standing at 57.27 kilograms (126 pounds).

Chinook are also known as “spring” salmon because they return to some rivers earlier than other Pacific salmon species.

This species is known as piscivorous, meaning that they eat other fish.

A favorite in the recreational fishery, the chinook salmon is known by many names: King, blackmouth, quinnat, and chub are all references to this powerful fish – with those over 14 kilograms (30 pounds) dubbed “Tyee”. Chinook spawn in large rivers from California to Alaska.

For the coastal Native Americans who originally inhabited Oregon, salmon served as the basis of life. They placed the salmon in very high esteem, holding special rites around the coming of the salmon and the spearing and roasting of the fish. Native American tribes, made special prayers of thanksgiving to their god for the salmon ,

In Oregon, the biggest runs happen in the Rogue, Umpqua, and Columbia rivers and the larger coastal streams,.

While swimming for up to 60 days from the ocean to their home streams, salmon do not feed and their stored body materials gradually dissipate.

Upon reaching home again, the female salmon deposits up to 14,000 eggs in gravel nests, where newly hatched youngsters then live for several weeks.

Young salmon consume plankton and later insects while in the streams, before moving on to creatures like herring, squid, pilchard, and crustaceans in the ocean habitat.

# Claudia Chinook

Claudia was built in 2003 by the *Rickreall Watershed Council* and given to Polk SWCD in 2010. Claudia was built to use as a tool to educate the public about healthy watersheds: what they are, how they work, and how you can do your part to help make watersheds healthy.



Claudia Chinook was built over the course of four months. She started as a wire frame, was covered in spray foam, fiberglass, and then painted.



She developed into a big, beautiful Chinook, standing a whopping 14 feet high and 29 feet long. The inside is big enough to hold 7-8 adults.
